### **Senior Manager - Facilities, Health and Safety, and Services at the State Laboratory**

The Senior Manager – Facilities, Health and Safety and Services is the Section Manager of the Laboratory Services section. This role demands a people-focused leader with the confidence and capability to manage, motivate, and develop staff. The successful candidate will champion best practice, foster an environment of excellence, and ensure that the section staff consistently delivers exceptional results. Working in tandem with other Section Managers and the Management Board, they will ensure high performance, strong collaboration, and seamless operational delivery. The successful candidate will demonstrate an ability to work cross-functionally to drive the effective implementation of a broad range of activities, including (but not limited to) those outlined below. They will also take on additional responsibilities assigned to the Laboratory Services section by the Management Board, contributing to the direction and continuous improvement of our operations.

#### **Who we are looking for**

The successful candidate will thrive in a collaborative environment, guiding the Laboratory Services section with confidence while fostering a culture of high performance and continuous improvement. The role involves steering a diverse range of operational activities. With strong people-management skills and a commitment to excellence, they will play a key role in shaping the smooth and effective running of our Laboratory. A strong interest in supporting the success of the Laboratory's chemistry function is essential, along with the ability to demonstrate a clear commitment to public sector values and to upholding the highest standards of chemical analysis and innovation that guide our work.

#### *Laboratory Location*

The State Laboratory is part of the Civil Service and has a staff of approximately 150 people who are mainly professional and technical. Situated at the Backweston Laboratory Campus on the Dublin/Kildare border, it is serviced by the C4 and L58 Dublin Bus Routes, with a shuttle bus service provided from nearby stations at Celbridge, Hazelhatch and Leixlip Louisa Bridge. Active transport is also encouraged with ample shelter for bicycles as well as shower and changing facilities. Car parking is provided for staff who wish to drive. Facilities on campus include walking trails, a staff restaurant and an on-site crèche facility (subject to availability).

#### *Work-life balance policy*

The nature of this role requires a majority on-site attendance with remote working possible on occasional days only. This role is not suitable for someone for whom remote working is essential.

## **Role of the Senior Manager – Facilities, Health and Safety, and Services in the State Laboratory**

We are recruiting a Senior Manager – Facilities, Health and Safety, and Services, who will be assigned as the Laboratory Services Section Manager. This is a senior management role in the Laboratory which involves co-ordinating and managing the work of the Laboratory Services section and the performance of staff in that section. The successful candidate will report to a member of Management Board and the role will involve working cross-functionally to oversee and ensure the effective implementation of a range of activities, including those described below. Other responsibilities may be assigned to the Laboratory Services section by Management Board. There is a significant people management dimension to this role and an accountability for the management and high performance of staff.

The Senior Manager – Facilities, Health and Safety, and Services is responsible for:

- Providing a strategic input into the general policies of the State Laboratory in consultation with the Laboratory's Management Board (MB) and with other Section Managers with a view to developing the professional capabilities of the Laboratory to meet the needs of client Departments / Offices;
- Supporting the MB in change delivery and policy implementation;
- Leading and managing the Laboratory Attendant Function to ensure this essential service meets the requirements of the Laboratory;
- Leading Health and Safety across the Laboratory, ensuring all legislative requirements are met and an excellent safety culture among staff and contractors is developed/maintained;
- Ensuring the Facilities and Services in the State Laboratory are fit-for-purpose through collaboration with internal and external stakeholders including the Office of Public Works (OPW) and the Facilities Management (FM) company;
- Leading energy efficiency, climate action and environmental sustainability across the organisation;
- Ensuring appropriate communication with both internal and external stakeholders for all areas under their remit;
- Managing the resources under their remit to provide a cost effective and efficient service, setting priorities in consultation with internal and external stakeholders, and making choices on the best way to allocate resources;
- Identifying opportunities for securing savings and efficiencies for the Laboratory;
- Planning, organising, supervising and managing the work of the section under their control;
- Managing and developing the staff in their section using the Performance Management and Development System (PMDS) and having significant oversight of the implementation of staff probation;
- Supporting the Laboratory's procurement processes, particularly in respect of the facilities and services requirements for laboratory equipment procurement;
- Leading and managing other laboratory/support services assigned by the Management Board.



## Responsibilities of the Laboratory Services Section

### (i) Laboratory Attendant Function

- Overall responsibility for management of the Attendant function;
- Liaises regularly with the Senior Laboratory Analysts of the section regarding management of the Attendant function across all analytical sections in the State Laboratory,
- Liaises with the Management Board regarding the Attendant function, both at business planning meetings and at other times as appropriate;
- Liaises with other Section Managers as appropriate;

### (ii) Health and Safety

- Overall responsibility for managing the implementation of Health and Safety; ensuring compliance with relevant legislation and best practice to ensure a safe environment for staff working on or off site, contractors and sub-contractors working on behalf of, and visitors to the State Laboratory;
- Ensure emergency preparedness procedures are implemented correctly and respond appropriately to emergencies or urgent issues as they arise, including contingency planning and business continuity planning.
- Make recommendations to the Management Board to ensure all legal requirements related to Health and Safety are met by the State Laboratory;
- Develop and implement fit for purpose Health and Safety policies;
- Liaise regularly with the Health and Safety Manager with respect to the Laboratory's Health and Safety Management processes including implementing procedures for managing risk assessments and the chemical inventory;
- Ensure an appropriate programme of safety audits are in place and completed; collaborate with the investigation of all Safety Accidents and Incidents and make recommendations to Management on actions to be taken to reduce occupational risk;
- Manage and be accountable for the risks identified in the Laboratory's Risk Register as relevant to the Laboratory Services Section in the Health and Safety arena to ensure relevant risks are recorded and monitored.
- Ensure there is representation of the State Laboratory at Public Sector working groups in the health and safety arena;
- Co-ordinate the actions and requirements of the labwide safety working groups.



**(iii) Facilities and Services Management**

- Overall responsibility for labwide FM functions;
- Liaise with the OPW with regard to all OPW held contracts, maintenance and ensure satisfactory standard of service is delivered;
- Liaise with the onsite FM company with regard to all operational activities, maintenance and ensure satisfactory standard of service is delivered;
- Liaise regularly with the Facilities and Services Manager to develop and implement a FM programme including preventative maintenance, in cooperation with the OPW /FM company manager, as appropriate; provide regular status reports and manage task lists and account progress for all project areas;
- Ensure the FM programme identifies the facilities, services and infrastructural requirements for a best in class analytical chemistry organisation. The programme must be consistent with current organisational needs, whilst planning for future changes and/or growth in service;
- Ensure emergency preparedness procedures are implemented correctly and respond appropriately to emergencies or urgent issues as they arise, including contingency planning and business continuity planning;
- Ensure accurate and complete recording of utility usage;
- Oversee energy consumption management to ensure that the Laboratory meets or exceeds public sector and other relevant energy consumption and climate goals,
- Manage and be accountable for the risks identified in the Laboratory's Risk Register as relevant to the Laboratory Services Section in the FM arena to ensure relevant risks are recorded and monitored;
- Ensure there is representation of the State Laboratory at Public Sector working groups in the FM arena;
- Co-ordinate the actions and requirements of the labwide FM working groups.

## Person Specification

### Essential Requirements, Qualifications and Experience

#### Educational Qualifications

##### Essential:

Candidates must on or before the closing date of this competition fulfil one of the following three options:

##### *Option 1 – Health and Safety Qualification:*

Candidates must on or before the closing date of this competition fulfil one of the following two sub-options:

##### *Sub-option A:*

hold a qualification of minimum Level 8 on the National Framework of Qualifications in Occupational Health and Safety, or, a relevant qualification which is acceptable to the State Laboratory Management Board as being at least equivalent, with either:

- (i) a minimum 2.2. Honours result

or

- (ii) a higher qualification (level 9 or 10 on the National Framework of Qualifications) in Occupational Health and Safety.

##### *Sub-option B:*

hold a qualification of minimum Level 7 on the National Framework of Qualifications in Occupational Health and Safety, or, a relevant qualification which is acceptable to the State Laboratory Management Board as being at least equivalent,

AND

hold a qualification of minimum Level 8 on the National Framework of Qualifications in Science, Engineering or another relevant subject, or, a relevant qualification which is acceptable to the State Laboratory Management Board as being at least equivalent, with either:

- (i) a minimum 2.2. Honours result

or

- (ii) a higher qualification (level 9 or 10 on the National Framework of Qualifications) in Science, Engineering or another relevant subject.

##### *Option 2 – Facilities and Services Qualification:*

Candidates must on or before the closing date:

hold a qualification accredited by Engineers Ireland at NFQ Level 8 or higher in a relevant area, e.g. Facilities Management, Building Services, Mechanical, Electrical or related engineering discipline.

### **Option 3 – Chemistry Qualification**

Candidates must on or before the closing date:

hold a qualification of at least Level 8 on the National Framework of Qualifications in Science with chemistry/analytical chemistry being the major component of the final year programme, or, a relevant qualification which is acceptable to the State Laboratory Management Board as being at least equivalent, with either:

- (i) a minimum 2.2. Honours result
- or
- (ii) an additional and higher qualification (level 9 or 10 on the National Framework of Qualifications) in Chemistry or Analytical Chemistry (where chemistry/analytical chemistry is the major component of the qualification).

#### **Desirable:**

Additional qualification(s) relevant to the role.

### **Experience, Skills and Behaviours**

#### **Essential:**

- A minimum of 5 years' relevant experience in at least one of the following:
  - Health and Safety
  - Facilities and Services
  - Operation of Laboratories in the State Laboratory
- Proven ability to manage client requests (internal or external clients), maintaining a customer focus and delivering on commitments while managing additional requests within the section resources;
- Excellent interpersonal skills, with a demonstrated ability to deal with management and staff at all levels, both within the organisation and externally;
- Experience supervising, managing, leading, motivating and developing staff in carrying out their duties;
- Proven excellent organisation, prioritization, record-keeping and time management skills;
- Proven ability to run projects from initial brief to completion;
- Proven flexibility to take on a role with a wide range of responsibilities and the frequent occurrence of high priority tasks at short notice;
- Experience in planning, organising, supervising and managing the work of a Section;
- Proven ability to plan and organise resources to meet objectives within agreed time-scales;
- Developed and maintained contact with peers in other scientific institutions and professional associations, both nationally and internationally.

#### **Note:**

In order to assure the shortlisting panel that you satisfy these requirements you must explicitly reference how you meet the requirements in your application. Failure to demonstrate these may prevent your application progressing to future shortlisting stages.

Candidates who come under consideration following the final selection stage will be required to provide documentary evidence of their eligibility, including qualifications and evidence of fluency in the English language.

Candidates who are unable to show that they hold the required qualifications may be withdrawn from the competition at any stage. An invitation to interview or any element of the selection process is not acceptance of eligibility.

## **Application, Competition Processes and Panel**

### **Application process**

All candidates should visit <https://www.statelaboratoryjobs.com> for the details of application. There will also be a link to the online application portal where all applications must be submitted.

This online portal is hosted by our external recruitment service provider Sigmar Recruitment and will allow eligible candidates to apply for this competition.

Please see Appendix 2 before for information on how to apply via Sigmar Recruitment.

Please take care when completing your application and ensure that you include all relevant details.

If the numbers applying are such that it would not be practical to interview all applicants, it may be necessary to shortlist only those that appear most suitable for the role of Facilities, Health and Safety, and Services Senior Manager based on the information submitted. Where shortlisting is required, the assessment process will include an assessment of candidates on the basis of the information contained in their application and may include a preliminary Interview.

### **Competition Process**

At interview, candidates will be asked to demonstrate their competence in the following disciplines:

- Leadership
- Analysis and Decision Making
- Management and Delivery of Results
- Interpersonal and Communication Skills
- Specialist Knowledge, Expertise and self-development
- Drive and Commitment

The interview will be a competency-based and you will be required to provide specific examples of past or current experiences where you have demonstrated the skills and competencies required for the role of Facilities, Health and Safety, and Services Senior Manager. These skills and competencies will be thoroughly examined at interview to determine suitability for the role. The same competencies and skill areas will be explored with all candidates. You may, at interview, be asked for additional examples of where you demonstrated the competencies and skills required for the role of Facilities, Health and Safety, and Services Senior Manager.

Please note: Your application and performance at interview will also be considered in the context of assessing communication skills.

Candidates called for preliminary interview and final interview must make themselves available on the date specified by the State Laboratory. It will not be possible to accommodate requests for date or time changes.

It is envisaged that interviews will be held as soon as possible after the closing date.

## Competition rules

### Availability and Admission

During the selection process, the onus is on all candidates to make themselves available on the date(s) specified by the State Laboratory and to make whatever arrangements are necessary to ensure that they receive communications sent to them at their contact details specified on their application form. Should their contact details change at any time during the competition or duration of the panel they must contact either the State Laboratory or Sigmar Recruitment by email notifying them of the change and providing the new details. The State Laboratory will not be responsible for refunding any expenses incurred by candidates. The admission of a person to a competition, or invitation to attend interview or a successful result letter, is not to be taken as implying that the State Laboratory is satisfied that such a person fulfils the requirements or is not disqualified by law from holding this position.

Prior to recommending any candidate for appointment from this competition, the State Laboratory will make such enquiries that are deemed necessary to determine the suitability of that candidate. Until all stages of the recruitment process have been fully completed, a final determination cannot be made, nor can it be deemed or inferred that such a determination has been made.

### Canvassing

Canvassing will disqualify candidates and will result in exclusion from the process. Candidates must not:

- Knowingly or recklessly provide false information
- Canvass any person with or without inducements.
- Impersonate a candidate at any stage of the process.
- Interfere with or compromise the process in any way.

In line with the Obligations of Candidates as set out in part 5, section 54-56 of the Public Service Management (Recruitments & Appointments) Act 2004 any person who contravenes the above provisions or who assists another person contravening the above provisions is guilty of an offence.

A person who is found guilty of an offence is liable to a fine and/or imprisonment. In addition, where a person found guilty of an offence was or is a candidate at a recruitment process, then:

- A candidate who has not been appointed to a post will be disqualified as a candidate.

AND

- Where a candidate has been appointed subsequent to the recruitment process in question, they will forfeit that appointment.

### **Deeming of candidature to be withdrawn**

Candidates who do not attend interview when and where required by the State Laboratory, or who do not, when requested, furnish such evidence, as the State Laboratory require in regard any matter relevant to their candidature, will have no further claim to consideration.

### **Use of recording Equipment**

The State Laboratory does not allow the unsanctioned use of any type of recording on its premises or any location where interviews take place, for example video interviews, teleconference. This applies to any form of sound recordings and any type of still picture or video recording, whether including sound recording or not, any form, and covers any type of device for these purposes. Any person wishing to use such equipment for any of these purposes must seek written permission in advance. The policy is in place to protect the privacy of staff and candidates/clients and the integrity of our assessment material and assessment processes.

Unsanctioned use of recording equipment by any person is a breach of this policy. Any candidate involved in such a breach could be disqualified from the competition and could be subject to prosecution under section 55 of the Public Service Management (Recruitment & Appointments) Act, 2004.

### **Appointments from the Panel**

Following completion of the Final Interviews, a panel will be established in order of merit. It is envisaged that **one** appointment will be made initially to the post of Senior Manager – Facilities, Health and Safety, and Services.

Appointments will be offered in order of merit.

## 1. Security Clearance

You will be required to complete and return a Garda eVetting form should you come under consideration for appointment. This form will be forwarded to An Garda Síochána for security checks on all Irish and Northern Irish addresses at which you resided.

However, should your application for the competition be unsuccessful this form will be destroyed. If you subsequently come under consideration for another position, you may therefore be required to complete a further Garda Vetting Form.

If you have resided / studied in countries outside of the Republic of Ireland for a period of 6 months or more, it is **mandatory** for you to furnish a **Police Clearance Certificate** from those countries stating that you have no convictions recorded against you while residing there. You will need to provide a separate **Police Clearance Certificate for each country you have resided in**. Clearance must be dated after the date you left the country. Candidates should be aware that if they come under consideration for a post their information will be shared with the Public Appointments Service in order to facilitate the vetting process. The Public Appointments Service has no involvement in the running or decision-making process of this competition but are facilitating the State Laboratory with the Garda Vetting process and will forward the results to the State Laboratory.

**It is YOUR responsibility to seek security clearances in a timely fashion as they can take some time. You cannot be appointed without this information being provided and being in order.**

## 2. Codes of Practice

The recruitment and selection process for appointment to these positions will be conducted in accordance with the Code of Practice for *“Appointment to Positions in the Civil Service and Public Service”* published by the Commission for Public Service Appointments (CPSA). The Code of Practice reflects the following core principles:

- Probity
- Appointments Made on Merit
- *An Appointments Process in Line with Best Practice*

- A Fair Appointments Process Applied with Consistency
- Appointments Made in an Open, Accountable and Transparent Manner

Candidates are advised to familiarise themselves with the contents of the Code of Practice including, amongst other things, the provisions in relation to the responsibilities placed on candidates who participate in the recruitment and selection process. The Code of Practice may be accessed by visiting [www.cpsa.ie](http://www.cpsa.ie).

### 2.1 Complaints and Requests for Review

Complaints/requests for review will be considered by the State Laboratory in accordance with the procedures set out in Sections 7 and 8 in the Code of Practice. Such complaints/reviews should be addressed to the State Chemist, Backweston Campus, Young's Cross, Celbridge, Co. Kildare. Where possible, the State Laboratory will attempt to initially deal with such matters informally as provided for in Sections 7 and 8.

### 2.2 Procedures where a candidate seeks a review of a Decision taken in relation to their application

A request for review may be taken by a candidate should they be dissatisfied with an action or decision taken by the State Laboratory.

The State Laboratory will consider requests for review in accordance with the provisions of Section 7 of the Code of Practice *Appointments to Positions in the Civil and Public Service* published by the Commission for Public Service Appointments (CPSA). When making a request for a review, the candidate must support their request by outlining the facts they believe show that the action taken or decision reached was wrong. A request for review may be refused if the candidate cannot support their request.

The Commission recommends that, subject to the agreement of the candidate, where the office holder (in this instance the State Chemist) considers the matter could be resolved they should first seek to engage on an informal basis, before making use of the formal review procedure.

### 2.3 Procedure for Informal Review

- A request for Informal Review must be made within 5 working days of notification of the decision and should normally take place between the candidate and a representative of the State Laboratory who had played a key role in the selection process.
- Where the decision being conveyed relates to an interim stage of a selection process, the request for informal review must be received within 2 working days of the date of receipt of the decision.
- Where a candidate remains dissatisfied following any such informal discussion, he/she may adopt the formal procedures set out below.
- If the candidate wishes the matter to be dealt with by way of a formal review, he/she must do so within 2 working days of the notification of the outcome of the informal review.

### 2.4 Procedure for Formal Review of Selection Process

- The candidate must address his/her concerns in relation to the process in writing to the State Chemist, outlining the facts that they believe show an action taken or decision reached was wrong.
- A request for review must be made within 10 working days of the notification of the selection decision. Where the decision relates to an interim stage of a selection process, the request for review must be received within 4 working days.
- Any extension of these time limits will only be granted in the most exceptional of circumstances and will be at the sole discretion of the State Chemist.
- The outcome must generally be notified to the candidate within 25 working days of receipt of the request for review.

### 2.5 Complaints Process

A candidate may believe there was a breach of the Commission's Code of Practice by the State Laboratory that may have compromised the integrity of the decision reached in the

appointment process. The complaints process enables candidates (or potential candidates) to make a complaint under Section 8 to the Secretary General, Department of Public Expenditure and Reform in the first instance and to the Commission for Public Service Appointments subsequently on appeal if they remain dissatisfied.

Allegations of a breach of the Code of Practice should be addressed in writing, and within a reasonable timeframe, to the State Chemist in the first instance. The complainant must outline the facts that they believe show that the process followed was wrong. The complainant must also identify the aspect of the Code they believe has been infringed and enclose any relevant documentation that may support the allegation. A complaint may be dismissed if the complainant cannot support their allegations by setting out how the State Laboratory has fallen short of the principles of this Code.

On receipt of a complaint the State Laboratory may determine to engage with the complainant on an informal basis.

### 3. Eligibility to compete and certain restrictions on eligibility

#### Citizenship Requirement

Eligible candidates must be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or
- (d) A non-EEA citizen who is a spouse or child of an EEA or UK or Swiss citizen and has a stamp 4 or a stamp 5 permission.

To qualify candidates must meet one of the citizenship criteria above by the date of any job offer

#### 3.1 Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility)

#### 3.2 Incentivised Scheme for Early Retirement (ISER)

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same

employment or the same sector. Therefore, such retirees may not apply for this position.

#### 3.3 Department of Health and Children Circular (7/2010)

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider public service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to compete in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

#### 3.4 Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will not be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. Thereafter, the consent of the Minister for Public Expenditure and Reform will be required prior to re-employment. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

### 3.5 Declaration

Applicants will be required to declare whether they have previously availed of a Public Service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment

### 3.6 Employer of Choice

As an **Employer of Choice** the Civil Service has many flexible and family friendly policies e.g. Worksharing, Shorter Working Year, Remote Working (operated on a 'blended' basis) etc. All elective policies can be applied for in accordance with the relevant statutory provisions and are subject to the business needs of the organisation.

The Civil Service also operates a Mobility scheme for all general service grades. This scheme provides staff with career opportunities to learn and partake in diverse roles across a range of Civil Service organisations and geographical locations.

## 4. Principal Conditions of Service

### 4.1 General

The appointment is subject to the Civil Service Regulations Acts 1956 to 2005 and the Public Service Management (Recruitment and Appointments) Act 2004 and any other Act for the time being in force relating to the Civil Service.

### 4.2 Starting salary and Payment arrangements

The salary scale for the position (rates effective from 1st August 2025) is as follows:

The PPC pay rate applies when the individual is required to pay a Personal Pension Contribution (otherwise known as a main scheme contribution) in accordance with the rules of their main/personal superannuation scheme. This is different to a contribution in respect of membership of a Spouses' and Children's scheme, or the Additional Superannuation Contributions (ASC).

A different rate will apply where the appointee is not required to make a Personal Pension Contribution.

Long service increments may be payable after 3(LS1) and 6(LS2) years satisfactory service at the maximum of the scale.

### Starting salary and Payment arrangements

Candidates should note that entry will be at the minimum of the scale and the rate of remuneration, including incremental progression, will not be subject to negotiation and may be adjusted from time to time in line with Government pay policy.

Payment will be made fortnightly in arrears by Electronic Fund Transfer (EFT) into a bank account of an officer's choice. Payment cannot be made until a bank account number and bank sort code has been supplied to the State Laboratory. Statutory deductions from salary will be made as appropriate.

**Important note:** Different terms and conditions may apply if immediately prior to appointment the appointee is already a serving Civil or Public Servant.

You will agree that any overpayment of salary, allowances, or expenses will be repaid by you in accordance with Circular 07/2018: Recovery of Salary, Allowances, and Expenses Overpayments made to Staff Members/Former Staff Members/Pensioners.

### 4.3 Tenure and Probation

The appointment is to a permanent position in the State Laboratory and by extension, the Civil Service, and will be subject to a probationary period.

The probationary contract will be for a period of one year from the date of appointment. Notwithstanding this paragraph and the paragraph immediately following below, this will not preclude an extension of the probationary contract in appropriate circumstances.

During the period of the probationary contract, an officer's performance will be subject to review by the appropriate supervisor(s) to determine whether the officer:

- (i) has performed in a satisfactory manner
- (ii) has been satisfactory in general conduct, and
- (iii) is suitable from the viewpoint of health with particular regard to sick leave.

Prior to completion of the probationary contract a decision will be made as to whether or not the officer will be retained pursuant to Section 5A(2) of the Civil Service Regulation Acts 1956-2005. This decision will be based on the appointee's performance assessed against the criteria set out in (i) to (iii) above. The details of the probationary process will be explained to the officer by the State Laboratory on commencement of employment.

Notwithstanding the preceding paragraphs in this section, the probationary contract may be terminated at any time prior to the expiry of the term of the contract by either side in accordance with the Minimum Notice and Terms of Employment Acts, 1973 to 2005.

In the following circumstances your contract may be extended and your probation period suspended.

- The probationary period stands suspended when an employee is absent due to Maternity or Adoptive Leave.
- In relation to an employee absent on Parental Leave or Carers Leave, the employer may require probation to be suspended if the absence is not considered to be consistent with the continuation of the probation and

- Any other statutory provision providing that probation shall -
  - (i) stand suspended during an employee's absence from work, and
  - (ii) be completed by the employee on the employees return from work after such absence.

Where probation is suspended the employer should notify the employee of the circumstances relating to the suspension.

All appointees will serve a one-year probationary period. If an appointee who fails to satisfy the conditions of probation has been a serving civil servant immediately prior to their appointment from this competition, the issue of reversion will normally arise. In the event of reversion, an officer will return to a vacancy in their former grade in their former Department.

#### **4.4 Duties**

The employee will be required to perform any duties appropriate to the position which may be assigned from time to time. The officer may not engage in private practice or be connected with any outside business which would interfere with the performance of official duties or conflict with his/her role in the State Laboratory.

#### **4.5 Location**

The State Laboratory is based in Backweston Laboratory Complex, Young's Cross, Celbridge, Co. Kildare.

When absent from home and headquarters on official duty, an officer will be paid appropriate travelling expenses and subsistence allowances, subject to normal Civil Service regulations.

#### **4.6 Hours of attendance**

Hours of attendance will be as fixed from time to time but will amount to on average not less than 41 hours and 15 minutes gross or 35 hours net per week. The successful candidate will be required to work such additional hours from time to time as may be reasonable and necessary for the proper performance of his/her duties subject to the

limits set down in the working time regulations.

Candidates should note that hours of attendance may be adjusted from time to time in line with Government policy.

#### **4.7 Annual Leave**

In addition to the usual public holidays the annual leave entitlement for this role (based on a full-time role) is 30 days per year.

#### **4.8 Sick Leave**

The rate of pay during properly certified sick absence, provided there is no evidence of permanent disability for service, will apply on a pro-rata basis, in accordance with the provisions of the sick leave circulars.

Officers who will be paying Class A rate of PRSI will be required to sign a mandate authorising the Department of Social Protection to pay any benefits due under the Social Welfare Acts direct to the State Laboratory. Payment during illness will be subject to the officer making the necessary claims for social insurance benefit to the Department of Social Protection within the required time limits.

#### **4.9 Health**

A candidate for and any person holding the office must be fully competent and capable of undertaking the duties attached to the office and be in a state of health such as would indicate a reasonable prospect of ability to render regular and efficient service.

#### **4.10 The Organisation of Working Time Act 1997:**

The terms of the Organisation of Working Time Act, 1997 will apply, where appropriate, to this appointment.

### **5. Secrecy, confidentiality and standards of behaviours**

#### **5.1 Official Secrecy and Integrity**

The appointment will be subject to the provisions of the Official Secrets Act, 1963, as amended by the Freedom of Information Acts 2014. Successful candidates will agree not to disclose to unauthorised third parties any

confidential information either during or subsequent to the period of employment

#### **5.2 Civil Service Code of Standards and Behaviour**

The officer will be subject to the Civil Service Code of Standards and Behaviour.

#### **5.3 Ethics in Public Office Act**

The Ethics in Public Office Acts 1995 to 2001 will apply, where appropriate, to this employment.

#### **5.4 Prior approval of Publications**

An officer will agree not to publish material related to his or her official duties without prior approval by the State Chemist.

#### **5.5 Political activity**

During the term of employment, the officer will be subject to the rules governing civil servants and politics.

#### **5.6 Personnel Code**

### **6. Superannuation and Retirement**

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at <https://singlepensionscheme.gov.ie/>

Where the appointee has worked in a pensionable (non-single scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age: The minimum age at which pension is payable is the same as the age of eligibility for the State Pension, currently 66.
- Retirement Age: Scheme members must retire at the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI

### 6.1 Pension Abatement

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension will be **subject to abatement** in accordance with Section 52 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012.

**Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position**

However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER, the Department of Health Circular 7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013, which renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements will, however be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

### 6.2 Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

### 6.3 Ill-Health Retirement

Please note any person who previously retired on ill health grounds under the terms of a superannuation scheme are required to declare, at the initial application phase, that they are in receipt of such a pension to the organisation administering the recruitment competition.

Applicants will be required to attend the CMO's office to assess their ability to provide regular and effective service taking account of the condition which qualified them for IHR. Appointment post

#### *Ill-health retirement from Civil Service*

If successful in their application through the competition, the applicant should be aware of the following:

1. If deemed fit to provide regular and effective service and assigned to a post, their civil service ill-health pension ceases.
2. If the applicant subsequently fails to complete probation or decides to leave their assigned post, there can be no reversion to the civil service IHR status, nor reinstatement of the civil service IHR pension, that existed prior to the

1. Where an individual has retired from a public service body his/her ill-health pension from that employment may be subject to review in accordance with the rules of ill-health retirement under that scheme.
2. If an applicant is successful, on appointment the applicant will be required to declare whether they are in receipt of a public service pension (ill-health or otherwise) and their public service pension may be subject to abatement.
3. The applicant will become a member of the Single Public Service Pension Scheme (SPSPS) upon appointment if they have had a break in pensionable public/civil service of more than 26 weeks.

#### **6.4 Pension Accrual**

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-

existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

#### **6.5 Additional Superannuation Contribution**

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017. **Note:** ASC deductions are in addition to any pension contributions (main scheme and spouses' and children's contributions) required under the rules of your pension scheme.
